It was observed at the time of the fire risk assessment that the entrance door to flat 55 was not able to close fully into the doorframe flush.	Works completed 9 <sup>th</sup> September	Complete
At the time of the fire risk assessment, there was a small breach into the lift motor room where the new fire alarm system had been installed.	Works completed 31 <sup>st</sup> Oct	Complete
It was observed at the time of the fire risk assessment that two communal fire doors were not able to self close fully and unaided into the doorframe. Door numbers were 1130 and 1142 on the ground and first floor.	Works completed 9 <sup>th</sup> September	Complete
At the time of the fire risk assessment, it was observed that some cupboards in the communal area, electric rooms/dry riser cupboards etc, were found to be used for storage of combustibles and equipment.	Works completed 16 <sup>th</sup> September	Complete
It was observed at the time	Repaired 19 <sup>th</sup> August	Complete
